To whom it may concern:

I have recently sent several Notices of Failure to Report a Crime and have sent sufficient evidence to support them. I'm still being ignored. Well, let me tell you, I have more unlawful acts to unveil, and your lack of action will soon put you and the company you represent in an uncomfortable place.

Today I want to call your attention to very serious actions that could have been committed in El Salvador and may well continue till today.
