

Guatemala, January 8, 2025

Miss Ana Lombardía and Mr. Luis Martínez:

It is appalling and inexcusable that an institution like AAA is letting such injustice take place under its nose and resist acting. This will come to light sooner or later, all acts and omissions that have permitted the Tribunal to act as they have till today, protecting a criminal, not only making it possible for Jorge Gaitan to have infinite funds to avoid justice in Guatemala and El Salvador, but rewarding him a large sum of money for it.

Yes, my husband told me Rainieri and Mandel promised him a bonus fee when the arbitration was final, a "reward" for his cooperation of more than a half a million dollars. I know this because he always talked about it, justifying what he was doing and the risk he was taking, stating it was not for him, but for his family. He told me several times, so we could buy our own house. He justified his actions, unlawful actions, for the "good of the family."

This makes you wonder about the motives of all the different agents that are involved in this mess. Jorge Gaitan and his father, their lovers (Carol Echeverria Guatemala and Jeny Torres in El Salvador), corrupt politicians, lawyers (in Guatemala a lawyer accused of attentive murder of her husband and the lawyer in El Salvador acts of possible money laundering), drug lords in El Salvador, and international criminals like Mr. Enrique Sanchez Hernández who was incarcerated in El Salvador; all of them have played their part in his unlawful activities. Now that I am no longer blind, now that I have seen with my own eyes documents that were in his desk in our room and the news, I know that he has always surrounded himself with criminals, acting in collaboration with them.

Peppertree, Goldman Sachs, Schachter, Carrillo, Alejos, Pinzon, all play their part for monetary reasons, knowing the truth, what he has done, how he has done it, with whom, protecting his actions in order to gain from the different legal procedures.

So now the question is, which part is the AAA playing? Do they agree with what it has already been made obvious? Will they permit, even to the last consequences and no matter what, a final award protecting, adding and abiding criminals like my husband, to be passed? What is their motivation? What will they gain? How will they be responsible for the consequences?

Do you think that this won't be scrutinized sooner or later by third parties, the press, set as an example of what is wrong with arbitration in America, the world? Arbitration is not free of corruption and justice may not be served in Arbitration; I am sure you know this.

When this case is reviewed, set as an example, will it be seen as model case of arbitration justice or the worst scenario of abuse of a panel and the lack of action of the AAA to intervene, to protect criminal activities? What will happen to your reputation, your name, the AAA reputation? Remember the case documents have already been made public on the web.

Recently I sent a previous letter stating that "Today I want to let you know that I was granted a constitutional motion ordering an illegal resolution to be revoked and reinstating my constitutional right to free speech. Justice has been served.", just to be mocked by Jorge Gaitan a few days later, posting a picture laughing with the criminal court building behind, stating "La Victoria es de Dios y es completa", post that a friend of mine share with me. I was granted a constitutional protection because my constitutional rights were violated as the result of a motion filed by his lawyers (which included the prohibition to post my opinions), but he has not been absolved, proven innocent, he is still being investigated for his criminal acts in Guatemala and in El Salvador. In El Salvador arrest warrants have been issued against him and his father. I do believe that justice will be served in his case too, sooner or later and he won't be laughing.

I have written to the arbitration panel several times asking for them to act, investigate, and stop financing and enabling Jorge Gaitán Castro, but I never got an answer. Now I ask of you, Ana Lombardía and Luis Martinez

to take action, do your job, stop protecting criminals and their actions thru arbitration, stop what is obvious.

My life could be in danger, my husband is involved in a International Criminal Organization, so its fair to say that I fear for my life and for the life of other members of my family. I have taken action if something happens to me, so everything that I know and have been witnessed to may come to light.
