On behalf of my client **María Cristina González Flores**, I am filing this complaint, to all institutions addressed, Arbitration Tribunal, American Arbitration Association, Gelber Schachter & Greenberg, P.A., Compliance Officer Goldman Sachs and Compliance Officer Peppertree.

Yesterday, January 26th, my client was cautioned by family and friends that something could had happened to her children, since Jorge Gaitán was with some of his family members, in front of a well-known shopping center (Plaza Etú), in Zone 14, Guatemala City Guatemala, surrounded by policemen and 2 police cars.

As soon as she received the news, she gathers more information, since Jorge Gaitán´s Lawyer, Ana Alejos, was posting on different social media platforms, statements about a "supposed" illegal detention, illegal warrant, and illegalities been committed (without mentioning

rights or stating the text or article of the law that was being violated).

All her actions, Ana Alejos, as you may see in her posts, are to pressure the different authorities to get her clients (Jorge Gaitan and his father) free, acts that may constitute obstruction of justice.

Since the Arbitration Tribunal, of the American Arbitration Association, Goldman Sachs, Peppertree, and Adam Schachter have enabled and provided funds for all my husband's legal defense, including personal family legal matters, you could all be held responsible for Ana Alejos actions, which may include actions against my client, violating her human and constitutional rights.

As you may know, obstructing justice is a serious offense that can have significant consequences for both a lawyer and their client, including the Arbitration Tribunal, of the American Arbitration Association, Goldman Sachs, Peppertree, and Adam Schachter, that previously have been made aware of the actions said lawyer has taken.

Yesterday, some acts by the lawyer Peppertree and Golman Sachs pay for the legal services she provides for Jorge Gaitán and his father, through Addam Schachter's office, may constitute a crime in Guatemala, and in El Salvador, since it was an international arrest warrant what was being executed that your Ana Alejos hinder.

Potential legal, professional, and reputational repercussions, said Lawyer and her clients, and other aiding them, could face, may include criminal charges for obstructing justice, which may include intimidating the authorities and interfering with legal proceedings. If the obstruction leads to harm to another party, civil lawsuits may follow, seeking damages.

Evidence of this obstruction, we can be sure, will be use in different cases in Guatemala to prove how Jorge Gaitán, his accomplices and his lawyers, act in bad faith.

Since these actions are all being funded by Peppertree and Golman Sachs, thru Adam Schachter's law firm, with consent and authorization of the Arbitration Tribunal, with unlimited funds, as he says (baking up his assertions on the Second Partial Award that he uses "prove his innocence" all criminal acts), all of them could be liable.

There is no need to remind you that Lawyers found guilty of obstructing justice risk losing their license to practice law, either temporarily or permanently. Bar associations often treat such ethical violations with zero tolerance. Lawyers' reputation could be also damaged.

Peppertree, Goldman Sachs, and the AAA members should be aware that obstruction cases can garner media attention, leading to negative public perception.

All involved must uphold their ethical duty to act within legal boundaries, even when zealously advocating for their clients. Obstructing justice undermines the judicial process, in this case not only in El Salvador, but in Guatemala, and consequences could reach each of you in the United States.

As I mentioned, this is a formal complaint, on behalf of my client, demanding that you act, investigate and stop any funding og Jorge Gaitán's legal personal matters, and illegal actions by him or his lawyers.
