## To whom it may concern:

I sent a letter on Friday May 17<sup>th</sup>. in Spanish to the company, that provides answers and context to all your question, but here let me provide much more information to you.

All the information submitted comes from our house, or what use to be our home, the home we have shared as a married couple and as a family for 16 years. My letters were sent to the last known address where Jorge Gaitan worked in Guatemala (very close to where we live actually). This is the closest and fastest way and place to deliver them, since delivering them to Ohio, New York or Miami would have been complicated. It makes no sense to deliver them anywhere else.

My life is in danger, and I need to do everything to get my daughters back from Jorge Gaitan, who claims to have unlimited funding for his legal defense. Continental Towers and its shareholders need to start answering my questions as people's lives are at stake.

Jorge Gaitan is paranoic and kept a lot of information to use it against other people, including messages from Rafael Briz asking him to delete them after reading them, but Jorge Gaitan did otherwise, knowing it was a way to manipulate people. I am not going into details because Gaitan is trying to manipulate courts in Guatemala the same way he did with the tribunal in USA, the partners of the company and the lawyers.

Gaitan told me that Carol Echeverria, Juan Ignacio Berger, Umaña and himself, extracted thousands of documents, computers, USBs and hard drives from the offices of his previous workplace in September of 2021. This is illegal. I used to work at a bank and if I had extracted one single document I would have been prosecuted.

My husband did not allow me to search the internet for his name or any news about him or his colleagues, until very recently I understood that I was a victim as well and I used to play the role that he imposed me, As I explain in my letter of Friday, criminal proceedings against him in El

Salvador and Guatemala was the main reason I was dismissed from my workplace. My former boss advised me to open my eyes because I was married to a criminal. Then I started looking at the internet and saw everything for, it didn't take me a lot of time to see all the public information available. I was horrified to see public documents of the case. in the USA where they exculpate him of any wrongdoing. They say that his testimony was found to be truthful. With proof that I have and what I know, only a con artist could convince an arbitral tribunal of this.

In the letter I presented on Friday I give a detailed explanation, to my best knowledge, of how he used the money given to him. Again, I think it is Continental Towers who must give explanations to me and not the other way around. If someone knows how the money is distributed is Adam Schachter. He knows how the money is circulated in detail, he coordinated payments with Goldman Sachs through Ropes and Gray, Peppertree through Katherine Polniff, Unger and John Ranieri, and everything had to be approved by Howard Mandel in Peppertree. Jorge Gaitán was always mad or frustrated with Howard Mandel and Peppertree because even though they ended up paying all of what he asked for without any apparent limit, there were always delays. He felt like Peppertree and Goldman had used him against the A Shareholder. He is a very resentful man, and he holds resentment not only towards the A Shareholders as he describes it, but also towards the B and C Shareholders. He told me he wants to sue Continental Towers if he does not get what he wants, so that the company cannot be sold. Most of the resentment towards the B and C Shareholders comes from the plan he presented to Peppertree where he wanted to partner with Michael Mackey from Everest Infrastructure Partners Company. His plan was for this company to buy Continental Towers and for Carol Echeverria, Juan Ignacio Berger and himself to receive stock of Continental Towers in exchange for managing the company. He even told Peppertree and Everest which countries he wanted and which ones he did not. For example, I remember saying he did not want Peru. In fact, he wanted to leave Continental Towers with his "management team" in the middle of the arbitration and start working with Everest. He became very resentful with Howard Mandel and John Ranieri because he claims that they had not allowed him to buy the company until arbitration ended and Peppertree needed him until the arbitration ended. He also stated that he had all in his favor all the tools to sink Peppertree and Goldman that he was irreplaceable, and that to some point he was dangerous to all of them, I guess this is why Peppertree pays all his legal bills and puts up with his tantrums. I have a feeling that Peppertree has offered him some kind of stock agreement,

and this is why Carol Echeverria claims to be stockholder of Continental Towers.

Jorge Gaitan and his collaborators have a resentful sick fixation towards Jorge Hernandez and all the people from his team, Strangely, before Jorge Gaitan used to speak very highly of him. I believe it was when Jorge Hernandez discovered the truth and realized who Jorge Gaitan really was, that Jorge Gaitan used his lies and strategies, and he had no choice but to turn his back on the one who had given him an opportunity for years. I remember one specific case when my husband almost died and was in intensive care, Mr Hernandez sent a special cardiologist to save his life. The company did everything possible to pay the hospital bills and got him his insurance. My Husband even falsely states his father, Jorge Gaitan Paredes, is the co-founder of the company, which is not true. He is dangerously fixated in taking the company away from Jorge Hernandez and his family. He asked Schachter to hire specialist to put Jorge Hernandez in the Magnitsky List, etc. This same uncontrolled hate is what I am experiencing now in my court cases. He invents and vilifies his adversaries destroying their name, so he comes out as the only true hero of the story. But he can't always be the hero, he can't always be a victim and anyone who buys this story is not smart enough, unless there are other reasons, convenient economic reasons to defend him.

I understand from what he told me, Howard Mandel does not like him, because he knows he is a liability for Peppertree and the Company.

Jorge Gaitan and Carol Echeverria sign as partners of Tandem Infrastructure, Sociedad Anónima. It is obvious this is an independent company of Continental Towers and did not sign this on behalf of it. He has always dreamed of having his own tower company. He signs this document in November 2021 and stopped working for the A Shareholder in September 2021. So, it's easy to understand that he did this for a personal gain. I don't think you would be asking me questions about Tandem if he had reported to all Shareholders about it. What he did tell me is that before leaving his workplace in September 2021, he had an agreement with Peppertree and John Ranieri where they could pay everyone that would leave DT, having prepared a fund to do this. This is what encouraged him to empty the offices and take all his most trusted people and information with him. He met with John Ranieri in August and he left on September 2021. Again, this sounds like this is not ethical.

In a message sent to Rafael Briz he refers to Jorge Hernandez stating, "He has more to lose" "He will not understand but I will" "I will take a plane to where it corresponds", meaning everything that happened on September 28th, 2021, was staged and premeditated. He had plans to do all of this regardless of what happened on the September 28th meeting. I remember that all his trusted team, Berger, Umana, and Echeverria were leaving the country on that date. This is why they emptied the computers and offices. On Friday I sent information where you may see that Juan Ignacio Berger indicates he extracted documents from the Backup they kept from DT, he also tells Gaitan and Echeverria that he got proof that Gaitan Paredes had signed contracts in El Salvador with the corrupt Vice President he is now being publicly accused of doing business with. This is another example of him possibly committing perjury before the Tribunal in the US, when he says he stole nothing.

I have given you all the information related to the removal of information of Hernandez Family Company, and I hope you expose Jorge Gaitan, so he stops this show and continues the pattern of lies. This way he learns the lesson that he can't lie his way through life and hopefully I will get my daughters back. People who are enabling my husband to pay millions in his defenses, portray him as a victim. He fooled all of you, his life was not in danger. We never had any threats, anyone perusing us or anything strange happening to us. In fact, he has been living in Guatemala and neither him nor his family has had any security problems. The only problem he has is with the authorities, because he and his collaborators are being accused of stealing information, computers and documents. It is his responsibility to face the consequences of his actions.

Money given to him has been used for Violence Against Women and Family Case specially against me, but it wouldn't be a surprise if he starts other actions against people he truly hates, that honestly have never actually harmed Jorge Gaitan. In some documents Ana Alejos states that she is his lawyer for the Continental Towers Case, and she is acting in others as his personal lawyer and taking away my daughters. Only someone who wants to be fooled may believe he is not using lawyers for his personal legal matters. You can see that even Schachter and Dechamps who I understood are Lawyers of the company, he uses as personal lawyers. They don't seem to have an objective approach to what he says and tells them to do on behalf of the company. They just do what he says. I only see Schachter meeting with the B and C Shareholders to coordinate the strategy and payments. I don't think he is behaving objectively at all.

I made an excel and attached it on my Friday letter based on recollection of what he said to me, invoices and estimated some expenses. You should tell me the exact amounts. I saw some invoices from Schachter, from Carrillo and others. I did not include all his lawyers and expenses in the Excell, but it was already ridiculous amounts of money for Latin American standards and to defend an "innocent" man.

To my recollection he and Carol Echeverria use an army of lawyers. Some of them are Dechamps, Schachter, Sequor Law, Gabriel Menocal, Emanuel Callejas, Rodrigo Callejas, Melody Pardo, Ana Alejos, Diego Bran, Mendizábal, Ordóñez and his lawyers in BVI.

I demand Continental Towers, Peppertree Capital and Goldman Sachs to give me the money back from my legal defense against a crooked "CEO" of Continental Towers.

My husband is trying to do with me what they describe doing in dreams to Jorge Hernandez. He is trying to gag me and prevent me from defending myself and get my family back. Whenever he accuses someone of doing something he is describing himself. Now you know and from now on you are responsible for anything that happens to me.

I would like to correct a paragraph from the letter I sent on Friday where I mention that all points to Carol Echeverria and Jorge Gaitan publishing the Golstein whistle blower article. my Friday letter, I state "Todo apunta que esta campaña negra no fue hecha por Carol Echeverría y Jorge Gaitán para engañar a los árbitros de la misma manera que los ha engañado a ustedes.", when it should say "Todo apunta que esta campaña negra fue hecha por Carol Echeverría y Jorge Gaitán para engañar a los árbitros de la misma manera que los ha engañado a ustedes."; which in English says: "Everything points to the fact that this black campaign was carried out by Carol Echeverría and Jorge Gaitán to deceive the referees in the same way that they have deceived you." Please take this into account.
